Campus Development Task Force Overview

With the University of Washington Tacoma acquiring additional property within the campus' *pawprint*, it is important to ensure that the development of the campus aligns with student needs and desires. The Campus Development Task Force has been established to gather student input and advocate for the expansion of the UW Tacoma campus.

With the passage of the 2024 ASUWT Constitution, ASUWT is mandated to have two task forces in operation each academic year, dedicated to advocating for the enhancement of specific aspects of the student experience at UW Tacoma. All ASUWT Task Forces, as mandated by the Constitution, are to operate under the guiding principles of data-driven advocacy to ensure that all initiatives are informed by accurate and relevant student data.


This strategic plan outlines the operations of the Campus Development Task Force for the next two academic years, detailing key performance indicators (KPIs) that must be met for the Task Force's stated goal to be met. The ASUWT Senate approved the original strategic plan in August 2024 and retains the authority to amend the plan and its KPIs as needed, as outlined in the ASUWT Bylaws.

Demonstrated Need

As UW Tacoma prepares for significant campus expansion, there is an **emerging need** to involve students in the planning process. UW Tacoma administration is expected to be in active discussions with a developer going forward, making it critical for ASUWT to have data on student preferences for academic buildings, lounge spaces, dining halls, residence halls, and other facilities ready for preliminary planning processes.

While UW Tacoma administration is expected to collect student input to inform their decision-making for the campus master plan, ASUWT needs to conduct its own research to verify their findings and to address any potentially overlooked student voices to ensure that all students are accurately represented.

Once the data has been gathered, the Campus Development Task Force will provide ASUWT with the necessary data to inform and influence how the campus should grow in a way that is student-centered.



Task Force Timeline



2024-2025

DATA COLLECTION AND INITIAL STUDENT ENGAGEMENT

Collect student data to inform advocacy efforts through surveys, focus groups, and town hall meetings; create formal ASUWT recommendations regarding campus expansion and hold advocacy meetings with decision-makers in administration.



2025-2026 ADVOCACY AND CONTINUED STUDENT ENGAGEMENT

Continue advocacy efforts, provide opportunities for additional student input, host events to inform the student body about upcoming campus developments, and conduct a follow-up survey to assess progress on KPIs.

Evaluate overall progress, determine if the taskforce needs to continue, and create a new strategic plan with updated KPIs if necessary.

- Finalize recommendations and proposals to administration
- Conduct end-of-year review of Task Force; modify strategic plan if needed
