- V. Open Public Forum
 - a. President Berry announced that he is spearheading an initiative to bring food trucks on campus and invited a few senators to help with the planning committee
- VI. Unfinished Business
 - a. Senate Quarterly Reports

- i. Senator Joshi
 - 1. For Office hours he's been available at 1 5pm at Pinkerton
 - 2. He's been checking his Email and discord routinely
 - 3. He's been communicating with the senate group and discussed potential initiatives
 - a. One initiative included addressing the major parking shortage for students on campus
 - i. A work in progress solution would be introducing a daily pass that can be traded in for Dawg bones
 - ii. He's still working on the logistics of this project and he'll update us as time goes on
 - iii. He will also present this to the Executive meeting
 - 4. Lastly, he's been meeting with the Dean of Urban Studies to discuss personal initiatives, quarterly check-ins, and campus security
 - Conor asked Senator Joshi if he's explored what event Grad students feel as if they're missing
 - a. Senator Joshi answered that the Tea Time is a significant event that gets mentioned a lot
- ii. Senator Rose
 - 1. Office hours are T/Th 12:30 3
 - 2. He's been collaborating with Maddie to implement a National College Health Assessment
 - a. He's been looking for incentives and funding for this initiative
 - b. The plan to implement late this quarter or next year
 - 3. Additionally, he's planning to create a Campus mental health and Wellbeing cohort to address mental health needs and concerns
 - 4. He attends the Executive meetings to represent the Senate every Friday evening
- b. CEI name Change Resolution
 - i. President Berry will be presenting the name Change Resolution and we'll be voting on it today
 - 1. For context, the CEI is attempting to change despite the backlash from the student body due to the significance of what Equity and Inclusion stand for

- ii. Senate Discussion:
 - Senator Bryant asked to know what the name change was and President Berry answered that the actual name shouldn't be the focal point because they don't want a name change
 - 2. Senator Whitmarsh asked why the vice Chancellor drawn this out to this extent and President Berry decided not to disclose that information to as to not stir confusion
 - 3. Director Williams asked if he was able to collect more quantifiable numbers regarding how many students opposed this change
 - President Berry couldn't provide an accurate count but through a public poll in the CEI overwhelmingly the voted against the name change
 - 4. Senator Abuli mentioned she hasn't seen much support for the name change
 - 5. President Berry mentioned that if this name changed it would create a bigger deficit on the school, which already has a thinly stretched budget
- iii. Director Williams entertained a motion to approve the Resolution
 - 1. Senator Rose motioned
 - 2. Senator Whitmarsh seconded
 - 3. The motion passed 6-0-0

VII. New Business

- a. Tabling Event Updates
 - i. Director Wetzel passed out informational sheets to provide updates on the Tabling events
 - 1. This includes the Senator's schedule, topics, set up etc.
 - 2. They plan to set up all the tables before the event starts
 - 3. More instructions will be provided on the day-off
 - ii. An additional event Director Wetzel mentioned will be the Fireside chat, that she encouraged the Senators to encourage the student body to attend
 - iii. Also Director Wetzel announced that there are open Senate positions to encourage other students to apply
 - iv. She asked to steer the image of the ASUWT away from "a group of students who do nothing and get paid for it"
- b. Constitution Review Committee

- i. Advisor Racheal and Connor have been working with Director Lealofi and Exec board to create a committee to update the constitution that hasn't been altered for almost a decade
 - 1. They encouraged the senators to join the committee if they're interested
 - 2. The meeting dates for this committee hasn't been announced but they'll plan to schedule a day that works for all of the members

- a. Director Whitmarsh met with Susan W. to discuss gun safety and the concerns that could hinder campus safety
 - i. In the scenario of the ongoing and the aftermath of an active shooter they are attempting to coordinate what the an effective safety
 - ii. Additionally, they were informed that the FBI would investigate students and she's unsure of the rights of students if they were investigated
 - iii. They've stated that this project his becoming larger than they've imagined and asked for assistance in moving forward with things such as
 - 1. Bringing a safety auditor to observe the school
 - 2. Restarting active shooter drills for the campus
 - a. Court 17 is a special case and would need further examination
